





Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 17, 2020 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2021 and ending December 31, 2021 is hereby approved; and





The 2021 Operating Revenues are \$1,728,827 compared to \$1,390,755 in 2020 an increase of \$338,072. The increase in expenditures is caused by the need to acquire new mobile radios mandated by the County and approved by virtue of special meeting held on 10/13/2020 through use of the reserve for future capital outlay and also proposed mandatory mail in February election ballots.

The 2021 Operating Revenues are \$1,728,827 compared to \$1,390,755 in 2020 an increase of 308,072. The increase in expenditures is caused by the need to acquire new mobile radios mandated by the County and proposed mandatory mail in election ballot cost.

Amount to be raised by taxation in 2021 is \$1,093,184 compared to 2020 of \$1,042,308. The proposed tax rate in 2021 is .0363 (3.63) per \$100 assessed valuation vs. .0346 (3.46) per \$100. assessed valuation in 2020. Unrestricted surplus utilized in 2020 of \$205,397. is less than in 2020 of \$394,292. by \$188,895. An average residential unit with an assessed valuation of \$403,014. will pay a fire tax of \$146.30 in 2021 compared to \$139.45 in 2020. restricted Fund balance of \$426, 102 is being used to finance the capital expenditures for mobile radios.
