Chief's Report

Equipment – Air packs have all had their annual inspections with the exception of three which will be done this month. There are no other reported issues at this time.

Drills - April 10th was the Chief's Test – Breakfast was at 8:15am and the drill began at 9:00am. The site for the drill was the old Clayton Concrete plant behind Nestle. This was an important deployment drill and ALL

members who attended were involved in various tasks. We then returned to the Main Base for a critique and lunch with many members of Station's 15, 16-1 and 19-2 who were all involved in the drill as well.

"Vehicle Positioning" drill on April 27th at a location I have yet to determine. The Chief's Test revealed some "issues" with positioning, which will be addressed and hopefully corrected.

Fill Stations in the storage cages are not in compliance with OSHA. Someone will need to find out what the standards are.

Iamrespoding.com teleconference was held with Asst. Chief Goldstein, VP Berman, Mr. Brass, Chief Palumbo, 2nd Lt. Murray and 1st Lt. Holley The cost for the system, computer and monitor for a 5 yr contract for \$650 – 5% per year for 24hour 7 day tech support Addt'l Costs would cap at \$300. Asst. Chief Goldstein is going to get costs of monitors and basic computers. This program would make it easier to contact your officers and to know who is available for calls for a particular day.

Old Business

Facial Hair Issue — it has been decided that a quantative fit test will be done to ensure that the members' masks are properly sealed. Asst. Chief Goldstein will find out the cost for this test.
