CHIEF REPORT

Chief Murray requests to purchase a new helmet for incoming Assist Chief in the amount of \$510.00 and new Shields for the new 2026 Officers in the amount of \$449.78. Board Approved.

This policy is in place to ensure safety, prevent accidents, and protect both personnel and equipment.
